Tender documents must be uploaded along with EMD (through Online), and the self attested copies of the following certificates, issued by the competent authority. MSME registered agencies are also eligible.

The contractor/agency is to satisfy the following conditions. Failing which the tender is liable for rejection.

Pre-qualification criteria of the agency (to be furnished along with technical bid document duly filled up).

1.1 Contractor's registration:

Self-attested up to date (renewed) contractors of appropriate class and category issued by the competent authority, (b) Valid electrical contract license, (c) Valid electrical supervisory license issued by the competent authority. (Note: 'b' & 'c' are applicable only for work sl. no. 4 & 5)

2.1 Experience of having successfully completed similar nature of works during last 7 years ending last day of the month previous to the one in which applications are invited:

(i) Three works each costing not less than the amount equal to 40% of the estimated cost of work.

Or

(ii) Two works each costing not less than the amount equal to 60% of the estimated cost of work.

or

(iii) One works each costing not less than the amount equal to 80% of the estimated cost of work.

And

One completed work (either part of above or a separate one) costing not less than the amount equal to 40% of the estimated cost with some Central/State Government Organization/Central Autonomous Body/Central Public Sector Undertaking in north eastern states.

Completion certificate for the construction of similar work(s) should be in prescribed format given in Proforma-6 of the technical bid document issued by the officer not below the rank of Executive Engineer of Govt./Semi Govt. Department.

3.1 Average annual financial turnover:

Average annual financial turnover on construction works should be at least 100% of the Estimated Cost during last 3 consecutive financial year ending 2020-21 duly signed by the Chattered accountant.

4.1 Financial solvency:

Financial solvency certificate issued by the Scheduled Bank as per proforma given in technical bid document (Proforma-2C) for amount not below 40% of Estimated cost during current financial year.

(i) Bankers certificates should be on letter head of the Bank in original address to the Director, NIT Silchar in sealed envelope.

(ii) In case of partnership firm, certificate should include names of all partners as recorded with the Bank.

5.1 G.S.T registration:

Self attested copy of G.S.T registration certificate. The agency should submit the GSTR-3B return along with payment receipt for the month of November, 2021.

6.1 EPF registration:

Self attested copy of EPF registration certificate including paid challan (not less than the minimum value) for the month of November, 2021.

7.1 PAN No.:

Self attested copy of PAN card.

8.1 An Engineer (Civil / Electrical) (For respective category of work), diploma with minimum five years experience in the required field or B.E. (Civil Engg) must be engaged by the contractor (Whose certificate duly self-attested, one copy photo & an undertaking by the Engineer in original is to be enclosed with the technical bid failing which the tender will not be considered) to supervise the work. The Engineer engaged must be familiar with all the works specified in the contract & must be acquainted with CPWD specification, manual etc. The engagement of engineer is not mandatory for Contractor possessing technical qualification.

Cost of Tender paper (Non refundable) & Earnest money (Refundable) are to be transferred through online.

- c) Registration/Enrolment of Bidder on e-procurement Portal of NIT Silchar:

In order to submit the Bid, the bidders have to get themselves registered online on the e-Procurement portal of National Institute of Technology, Silchar with valid Digital Signature Certificate (DSC) issued from any agency authorized by CCA and which can be traced up to the chain of trust to the Root Certificate of CCA. The registration should be in the name of bidder, whereas DSC holder may be either bidder himself or his duly authorized person.

The bidders will have to accept unconditionally the online user portal agreement which contains the acceptance of all the Terms and Conditions of NIT (Notice Inviting Tender) including Commercial and General Terms & Conditions and other conditions, if any, along with on-line undertaking in support of the authenticity of the declarations regarding the facts, figures, information and documents furnished by the Bidder on-line in order to become an eligible bidder. No conditional bid shall be allowed / accepted.

The bidder will have to give an undertaking online that if the information/declaration/scanned documents furnished in support of the same in respect of eligibility criteria are found to be wrong or misleading at any stage, they will be liable to be punitive action.
