1. Secondary/High School/Higher Secondary/equivalent certificate, issued by the Education Board and not by the Principal/Headmaster of the School/Institution where studied, as proof of age.
2. All certificates and Grade / Mark sheets in support of your educational / professional qualifications at all levels.
3. If the applicant is employed in Government / Semi – Government organization and his / her application has not been forwarded through proper channel, a “**No Objection Certificate**” from his / her present employer to this effect.
4. Certificates issued by Competent Authority in support of **experience**, if any, indicating the nature of duties performed.
5. Certificates issued by the Competent Authority in support of SC/ST/OBC/EWS/PWD, if applicable.
6. Relevant certificates / documents in support of all claimed credentials in respect of essential / desirable requirements as per advertisement and as claimed by you in your application.

The candidature is **provisional**. Therefore, the candidates must ensure with documentary proof that they fulfill all the criteria adopted for shortlisting. If at any stage it is found that they do not fulfill any of the criteria adopted for shortlisting, their candidature will be cancelled and no appeal against such cancellation will be entertained. The fact that they have been called for interview does not confer any right on them to be treated as eligible in all aspects for appointment or to be considered for interview.

Please note that **date, time and venue of interview** is final and no request for change will be entertained. In case the candidate fail to attend the interview, it will be presumed that he / she is not interested in the post and his / her candidature will be treated as '**cancelled**'. No further correspondence will be entertained in this regard. **The candidate must be prepared to stay one more day after the schedule date of interview.** No TA/DA will be provided for appearing in the interview.
