The Director, National Institute of Technology Silchar-10, invites sealed item rate tender from experienced, financially sound contractor/agency of appropriate class and category (Civil work sl no. 1,2,3,4 & 5 and Road work for sl no. 6, 7 & 8), registered with Central PWD, Assam PWD, MES, Railway, BSNL and nationally reputed firm only for the works detailed below:

Pre-qualification criteria of the agency (to be furnished along with technical bid document duly filled up).

1.1 Contractor's registration:

Self attested up to date (renewed) contractors registration certificate of appropriate class and category issued by the competent authority.

2.1 Experience of having successfully completed similar nature civil works for Sl. No. 1 & 2 and road work for Sl. No. 3, 4 & 5 during last 7 years ending last day of the month previous to the one in which applications are invited:

(i) Three works each costing not less than the amount equal to 40% of the estimated cost of work.

or

(ii) Two works each costing not less than the amount equal to 60% of the estimated cost of work.

or

(iii) One works each costing not less than the amount equal to 80% of the estimated cost of work.

and

One completed work (either part of above or a separate one) costing not less than the amount equal to 40% of the estimated cost with some Central/State Government Organization/Central Autonomous Body/Central Public Sector Undertaking in north eastern states.

Completion certificate for the construction of similar work(s) should be in prescribed format given in Proforma-6 of the technical bid document issued by the officer not below the rank of Executive Engineer of Govt./Semi Govt. Department.

Average annual financial turnover on construction works should be at least 30% of the Estimated Cost during last 3 consecutive financial year ending 2014-15.

4.1 Financial solvency:

Financial solvency certificate issued by the Scheduled Bank as per proforma given in technical bid document (Proforma-2C) for amount not below 40% of Estimated cost during current financial year.

- (i) Bankers certificates should be on letter head of the Bank in original address to the Director, NIT Silchar in sealed envelope.
- (ii) In case of partnership firm, certificate should include names of all partners as recorded with the Bank.

5.1 VAT registration:

Self attested copy of current/renewed VAT registration certificate.

6.1 EPF registration: (Except Sl. No. 3, 4, 5)

Self attested copy of EPF registration certificate including challan current for the financial year.

7.1 PAN No.:

Self attested copy of PAN card.

Tender documents are to be submitted in 3 (three) separate envelopes. 1st envelop should contain Earnest Money, 2nd envelope should contain pre-qualification (technical bid) duly filed up & signed along with relevant document as prescribed, and 3rd envelope should contain the price bid. **All 3 (three) envelopes are to be sealed in a single envelope, mentioning name of work, NIT No., closing date and time.** The 3rd envelope containing price bid will be opened only for those contractors who are technically qualified as per conditions of NIT.

Request for issue of tender bid document will be received up to 04:00 pm on **24.08.2015** and the bid document will be issued till **26.08.2015** up to 04:00 pm. The completed bid document will be dropped in the tender box available at Estate Engineering Branch of the Institute up to 02:00 pm on **28.08.2015** and will be opened at 3.00PM on same day and price bid of the technically qualified agency will be opened on **02.09.2015** at 03:00 pm in presence of agencies or authorized persons thereof.

Earnest money should be deposited in the shape of (i) Deposit at Call receipt of a scheduled Bank guaranteed by the Reserve Bank of India or (ii) Bankers cheque of a scheduled Bank or (iii) Fixed deposit (FDR) of a scheduled Bank.

Tender of any contractor not accompanied with proper earnest money and incomplete tender, non submission of requisite documents (Self attested) under Sl. 1.1 to 7.1 of the NIT or in any form shall be summarily rejected.

If any, holidays / strike falls during the notified days, the process will be continued on next working day.
