The contractor / agency are to satisfy the following conditions. Failing which the tender is liable for rejection. Pre - qualification criteria of the agency (to be furnished along with technical bid document duly filled up).

1.1 Contractor's registration:

Self-attested up to date (renewed) (a) contractors' registration certificate of appropriate class and category (b) electrical contract license, (c) electrical supervisory license issued by the competent authority.

2.1 Experience of having successfully completed works during last 5 years ending last day of the month previous to the one in which applications are invited:

(i) Three similar works costing not less than the amount equal to 40% of the estimated cost

Or (ii) two similar works costing not less than the amount equal to 60% of the estimated cost.

Or (iii) one similar works costing not less than the amount equal to 80% of the estimated cost.

Completion certificate for the construction of similar work(s) should be issued by the officer not below the rank of Executive Engineer of Govt. / Semi Govt. Department.

3.1 GST Registration: Self attested copy of GST registration certificate.

4.1 EPF registration: Self attested copy of EPF registration certificate including challan current for the year.

5.1 PAN No: Self attested copy of PAN card.

The documents are to be submitted in two separate envelopes. 1<sup>st</sup> envelop should contain Technical documents, 2<sup>nd</sup> envelope should contain the price bid.

**The 2(two) envelopes are to be sealed in a single envelope, mentioning name of work, closing date and time.** The 2<sup>nd</sup> envelope containing price bid will be opened only for those contractors who are found technically qualified as per conditions of quotation notice.

Request for issue of tender bid document will be received up to 1:30 pm on **18/10/17** and the bid document will be issued till **18/10/17** up to 04:00 pm. The completed bid document will be allowed to drop in the tender box available at Estate Engineering Branch of the Institute up to 02:00 pm on **23/10/17** and will be opened at 03.30 pm on same day. The price bid of the technically qualified agency will be opened on **24/10/17** 3.30 pm in presence of agencies or authorized persons thereof.
