2. All certificates and Grade / Mark sheets in support of your educational / professional qualifications at all levels.
3. If the applicant is employed in Government / Semi – Government organization and his / her application has not been forwarded through proper channel, a "**No Objection Certificate**" from his / her present employer to this effect.
4. Certificates issued by Competent Authority in support of **experience**, if any, indicating the nature of duties performed.
5. Certificates issued by the Competent Authority in support of SC/ST/OBC/PWD, if applicable.

6. Relevant certificates / documents in support of all claimed credentials in respect of essential / desirable requirements as per advertisement and as claimed by you in your application.

The candidature is **provisional**. Candidates must, therefore, ensure with documentary proof that they fulfill all the conditions of eligibility. If at any stage it is found that the candidate do not fulfill any of the conditions of eligibility, his candidature will be cancelled and no appeal against such cancellation will be entertained.
