It is with this end in view MoU with the following Universities/organizations has been signed.

As per Statute 14 (iv) of the First Statute of NITs, the Chairperson, BoG has approved the Annual Report and Audited Accounts for the year 2021 - 22 on 23.12.2022 (Annexure - III2) and required copies of the Annual Report and Audited Accounts (both Hindi & English) were submitted to the MoE on 30.12.2022.

Minor change in the names of the proposed i-TBI Section-8 Company. The proposal submitted for setting up Inclusive Technology Business Incubator (i-TBI) at National Institute of Technology Silchar, Silchar has been recommended by National Expert Advisory Committee (NEAC) to support under NIDHI i-TBI program subject to administrative and financial approval by DST. As per the proposal, it was proposed that a space of 11500 sqft will be provided to host the Inclusive-Technology Business Incubator (i-TBI). The proposed total project cost was Rs.374 lakh and support sought from DST was Rs.165 lakh in capital and Rs.106.90 lakh in recurring under Digital Technologies. It was recommended that the target milestones shall be made more realistic. The committee recommended that the budget as per DST's funding norms (Annexure – IV₁) for iTBI may be considered for support

As a Mandate of ITBI, NIT Silchar needs to start a section-8 company under the ministry of corporate affairs in its online portal. The 91st meeting of the BOG held on 11.08.2022 approved either of the following three names for i-TBI Section-8 Company:

- 1. NIT Silchar Centre for Innovation, Incubation, and Entrepreneurship
- 2. NIT Silchar Centre for Inclusive Technology Business Incubation
- 3. NIT Silchar Centre for Digital Technology Business Incubation

However, while submitting proposals in online mode to the Ministry of Corporate Affairs, Govt. of India none of the above three names have been accepted. However, the system has suggested for resubmitting the names with inclusion of either of the words Foundation/ Forum / Association / Federation / Chamber / Confederation, etc as per Rule 8A(1)(u) of the Companies (Incorporation) Fifth Amendment Rules, 2019.

Accordingly, our approved CA firm M/S Anil Hitesh and Associates (91st BoG held on 11/08/2022 with item number BoG 91/22/10-B) recommended the following names for submission in the online portal.

Extension of the outsourced agency providing security, housekeeping & gardening services beyond 31.12.2022

NIT Silchar engaged M/s Vanguard Security Service & Systems (VSSS) for providing 4 types of services viz Campus Housekeeping Services, Campus Security Services, Gardening, and Housekeeping services at all Hostels since 2020/2021. It was observed that the tender was floated on 23.03.2022 and was cancelled on 20.04.2022 citing the reason that it involves a major financial decision and the tenure of the then Director was to be completed on 30.11.2022. Subsequently, two nos viz. Campus Housekeeping (except Hostels) and Campus Gardening works services were extended more than 23 months each after the expiry of their contract period whereas, for Hostel Housekeeping

and Campus Security Services, the period of the contract was extended by 18 & 12 months respectively i.e till 31.12.2022 by the Competent Authority.

The extended tenure of engagement of M/s Vanguard Security Services & Systems expired on 31.12.2022.

A committee under the Chairmanship of Dean (P&D) was constituted vide No. NITS/Tech/491/08/Pt-VII/18-19/2303-09 dated 05.12.2022 to initiate and finalize the processing of fresh tender for 4 nos of service-related works. The proposals of the committee, submitted on 21.12.2022 were discussed in a meeting chaired by the Director and attended by all Deans and Officers of the Institute on 22.12.2022. The resolution of the committee is attached as Annexure-V₁.

Further, the committee vide resolution No. 3 recommended that "since the period of contract is extended up to 31.12. 2022, the Institute is under compulsion to extend the further contract period of the present agency/contractor beyond 31.12.2022 else it will paralyze the whole system i.e security and daily maintenance of NIT Silchar. As such it has been decided to extend the period of the Contract for another 3 months with the same terms and conditions or till the award of the work to the agency/ies after due tender process whichever is earlier."

The entire matter was submitted before the Chairman, BOG for his approval, with the observation that it would be placed in the next meeting of the BOG for ratification. The Chairman, BOG vide his email dated 26.12.2022 replied to Director, NIT Silchar as under:

"I have perused the decision of the committee and also discussed the same with you. Since we have very little time left there is no other option but to extend this contract by 3 months or till the finalization of the tender whichever is earlier. The extension will (be placed) in the meeting of the BOG."

The email is placed as Annexure- V_2 .

Accordingly, letters for extension of the contract of all 4 services for three months with effect from 01.01.2023 or till the award of work to agency/ies after due process of the tender have been issued. These letters are placed as Annexures- V_{3-6} .

The matter is placed before the Board for ratification.

- ii) In order to save time, tender is to be floated immediately without waiting for confirmation of minutes.
- iii) If tender process and award of work by following observation(i) takes more than 3 (three) months, the current contract may be extended further, till the finalisation of contract and award of work with the approval of the Chairperson, BoG
- iv) The minimum contract period should be for a period of 2 (two) years extendable by 1 (one) more year subject to satisfactory performance with an explicit clause for termination by the Institute within the contract period by giving 1 (one) months' notice.

Recommendation of the committee constituted for enhancement of consolidated pay of staff engaged on contractual basis

The consolidated pay of contractual staff of the institute was revised in 2018 and 2020 @ 3% (compounded) for 2 (two) years. However, no increment was granted to them during the year 2022. In this regard, a committee has been constituted by the Director, NIT Silchar to look into matters related to the enhancement of the consolidated pay of staff engaged on contractual basis.

The Committee constituted has made two recommendations which are as follows:

a) RECOMMENDATION - I

In the recommendation of 7^{th} CPC the minimum pay for an employee of the institute is $\stackrel{?}{=}$ 18,000.00 (i.e. Level - 1, Cell - 1). Few staff engaged on contract basis are getting pay less than $\stackrel{?}{=}$ 18,000.00;

- i. the, consolidated pay of staff who are getting less than ₹ 18,000.00 may be enhanced to ₹ 18,000.00 w.e.f. January, 2022
- ii. the staff whose consolidated pay is more than ₹ 18,000.00 may be given an annual increment @ 3% compounded for 2 years (as per earlier practice) w.e.f January, 2022
- iii. the staff whose consolidated pay is more than ₹18,000.00 and were granted an increment during the year 2021 will be given an increment @ 3% only w.e.f. January, 2022

RECOMMENDATION - II

- As per earlier practice, contractual staff may be given an annual increment @ 3% compounded for 2 years w.e.f January, 2022.
- The contractual staff who were granted an increment during the year 2021 will be given an increment @ 3% only w.e.f. January, 2022

The Competent Authority may decide on either of the recommendations.

The retired staff engaged on contract basis and who are getting pension in addition to consolidated pay may not be given any increment

The recommendation of the Committee is placed in Annexure - VIII.

The Board is requested to peruse the above two recommendations and approve either of the two recommendations at (a) above.

Grant of Child Care Leave to a Female Faculty Member under probation Dr. Binita Nath, Assistant Professor Grade – II, Department of Mechanical Engineering vide letter dated 15.12.2022 (Annexure – IX) requested to grant her Child Care Leave for the period from 12.01.2023 to 12.05.2023. Dr. B. Nath joined the institute on 11.07.2022 and is still under probation.

As per Rule, 43 (C) of CCS (Leave) Rules a female Government servant and single male Government servant may be granted child care leave by an authority competent to grant leave for a maximum period of seven hundred and thirty days during entire service for taking care of two eldest surviving children, whether for rearing or for looking after any of their needs, such as education, sickness and the like. Further for this purpose child means, a child below the age of eighteen years.

In addition to this, Rule 43 (C) (3) (iii) states that it shall not ordinarily be granted during the probation period except in case of certain extreme situations where the leave sanctioning authority is satisfied about the need of child care leave to the probationer, provided that the period for which such leave is sanctioned is minimal.

Dr. B. Nath has only one daughter. The case of Dr. B. Nath is extreme in the sense that age of her daughter is 6 months and need special care, as her daughter is dependent on her for every basic needs.

The Board is requested to consider and approve the request of Dr. Binita Nath for grant of Child Care Leave for the period from 12.01.2023 to 12.05.2023.

DECISION

It was explained before the Board that the case of Dr. Binita Nath, Assistant Professor Grade – II (under probation) falls under Rule 43 (C)(3)(iii) of CCS (Leave) Rules as recommended by the HoD, Mechanical Engineering. As such, the Board granted her Child Care Leave for a period of 4 (four) months under Rule 43 (C)(3)(iii) of CCS (Leave) Rules.

- Incumbent was granted promotion to the post of Senior Technical Assistant (Level - 7) w.e.f. 05.09.2022 on the basis of recommendation of DPC.
- c. As per the NITs Non Teaching Recruitment Rule 2019 for promotion to the post of Senior Technical Assistant the eligibility criteria is at least 5 (five) years regular service as Technical Assistant in PB II with Grade Pay ₹ 4,200.00 or at least 5 (five) years combined service of Technician (SG I) and Technical Assistant in PB II with Grade Pay ₹ 4,200.00 through DPC and working performance record, through prescribed test and interview. Sri M. Shekhar has completed five years of service on 21.06.2021,
- d. As per guidelines of Departmental Promotion Committee the DPCs should be convened at regular annual interval to draw panels which could be utilised on making promotions against the vacancies occurring during the course of a year.
- The meeting of DPC was not conducted during the year 2021 due to COVID – 19 (Omicron).

In view of the above the committee resolved that the delay in conduct of DPC and promotion in case of Sri M. Shekhar was an Administrative lapse for which Sri M. Shekhar cannot be victimised. As such, it is proposed that Sri M. Shekhar may be granted promotion form the date of eligibility i.e. 22.06.2021

The recommendation of the Committee is placed at Annexure - X2.

The Board is requested to consider and approve the request of Sri. M. Shekhar for granting him promotion w.e.f. 22.06.2021.

Re-engagement of Superannuated Faculty Members as Visiting Faculty as per adopted Model Recruitment Rules for Faculties of NITs.

NIT Silchar is one of the most premier technical institutes in Eastern India. At present the institute is catering 6 UG programmes, 21 PG programmes and PhD programmes in all the academic departments of the Institute. At present a total of 216 faculty members out of 282 sanctioned posts are working at different grade levels. The Institute being located at a remote place is experiencing high attrition of senior and experienced faculty member strength at higher levels. In this connection it is to be mentioned that percentage of senior and experienced faculty always remain very poor for this institute eg. at present the said percentage approximately 11 percent of the total sanctioned strength. In view of this, retaining senior and experienced faculty members after superannuation is required for maintaining quality of education and research in the institute.

As per 'Model Recruitment Rules for Faculties of NITs', issued by the Ministry of Education, GOI willing retired academic persons may be appointed as a visiting faculty with or without remuneration for a maximum duration of two years by the Director of an institute.

Considering the need of the department, HOD of Civil Engineering has sent a request to re-engage Prof S Choudhry, who is retiring on 31st January 2023 to meet the existing faculty shortages at higher levels in the department. It may be mentioned that as per recruitment rule "visiting faculty" for an NIT can be appointed by the Director on mutually agreed honorarium and facilities.

It is proposed that Prof S Choudhury may be appointed as a visiting faculty to the department of Civil for a period of 2 (two) years, on the following terms and conditions.

Monthly salary: Last pay less by pension amount, subject to the condition that pension plus monthly salary should not exceed maximum HAG pay. The incumbent will be allowed to attend 1 (one) national conference/ seminar in a year and the expenditure will be reimbursed as per the institute rule. Casual leave, Special casual leave and medical leave will be admissible as per institute norms. Accommodation in the campus will be provided on request, if available.

The Board is requested to consider and approve the proposal.

DECISION

The Board approved to appoint Superannuated Faculty Members of this institute as Visiting Faculty. Further, the Board authorised Director to appoint Superannuated Faculty Members from various Departments of the Institute as Visiting Faculty based on the recommendation of concerned Heads of the Departments under the following terms and conditions:

- Appointment will be initially for a period of 1 (one) year extendable by 1 (one) more year
- > Consolidated monthly pay will be Last Pay Drawn minus Pension
- Attending 1 (one) national conference/ seminar in a year and expenditure will be reimbursed as per the Institute rule
- Casual Leave & Special Casual Leave as per the norms of the Institute.
- Accommodation may be provided in the campus, subject to availability else fixed HRA as decided by the Director will be paid.

NIT Silchar has started PhD program long back and at present there are 500 nos. of PhD scholars with MoE assistantship. Now, proposal from the department have been received for starting PDF at NIT Silchar. It may be mentioned here that other NITs of similar infrastructure and academic facilities have started the PDF program long back.

The Senate in its 78th meeting scheduled on 19.01.2023 in principle approved the proposal for starting Post-Doctoral Fellowship at NIT Silchar and recommended the same to BoG for approval.

The Senate deliberated on it and approved the proposal. It is to be informed that it has no financial liability except the utilisation of the Institute infrastructure. Adoption of Payment of Gratuity Act, 1972 for the employees of this institute who are under NPS.

The Ministry of Education vide OM F. No. 15-2/2022-TC dated 16.12.2022 (Annexure – XIV₁) has advised Ministry to instruct Autonomous Bodies/ Organizations to adopt Payment of Gratuity Act, 1972 in consultation with MoL&E since CCS (Pension) Rules, 1972 are strictly meant for Central Government employees only. Further, vide O.M. No.R-13011/02/2022-SS.II dated 23.11.2022, the MoL&E has clarified that the Payment of Gratuity Act, 1972 is applicable to all employees of Educational institutions, as the said Act does not have provisions for different set / category / class of employees and further that no separate notification is required to be issued by the Ministry of Education for applicability of the said Act (in case of NPS employees).

The Board is requested to allow the institute to adopt Payment of Gratuity Act, 1972 (Annexure – XIV₂) for the employees of this institute who are under NPS.

The Board approved the adoption of Payment of Gratuity Act, 1972 for the employees of this Institute who are under NPS.
