The Senate then initiated the discussion on the agenda items and the following resolutions were adopted.

S-83/23/04: To consider and recommend awarding various medals at the 21st Convocation to the graduating students (B.Tech., M.Tech., M.Sc. and MBA) who have been found eligible for the same

A committee comprising of all HoD's & Dr. T. Khan, Assoc. Dean (Acad) as Convenor was constituted to finalise the name of the medal winners in various disciplines of UG & PG Program.

- (a) The Institute is offering a Best Doctoral Award (gold plated medal). The award is presented to the one who is found to be the best performer in his/her Ph.D work, among the Ph.D Degree recipients in a given Convocation.
- (b) The Institute is offering a Best All Round Graduate Award (gold plated medal). The award is presented to the one who is found to be the best all round performer among the B.Tech. Degree recipients in a given Convocation.
- (c) The Kalikrishna-Mrinalini Deb Krori Award (gold plated medal) is awarded to the best engineering graduate and is sponsored by Prof. K.D Krori, former Principle, Cotton College in memory of his parents. The award is presented to the best degree recipient among the B.Tech. Degree recipients in a given convocation.
- (d) The Saswata Purkayastha Memorial Award (gold plated medal) is awarded to the best Gymkhana member. This award is sponsored by the parents of Late Saswata Purkayastha who was a General Secretary of the students' Gymkhana and died in a tragic road accident. The award is limited amongst outgoing students who were members of the Students' Gymkhana.

S-82/23/19 (E) wherein the Senate decided that these students may be asked to join the UG program next year i.e. in 2024 subject to fulfilment of the conditions for admission and clearance from the ICCR. The same was informed to the ICCR on 16 Oct 2023. However, ICCR vide email dated 18 Oct 2023 requested to reconsider their admission in the current academic year, since as per ICCR norms the admission cannot be deferred to next year.

Considering the reply of ICCR and future of the candidates, they were allowed late admission in UG 1st semester in the ongoing session.
