1. The candidate who are provisionally selected for admission to the MBA Programme 2025-27 of the Department of Management Studies, NIT Silchar have to submit the **Registration Fee for the First Semester as follows through online** on or before **4<sup>th</sup> June, 2025 (Wednesday)**.

2. The candidates are advised to submit the requisite amount of Registration Fees **ONLINE** through **SB Collect portal**. This portal will be active to receive the Registration Fee for the selected candidates for MBA Programme 2025-27 from **29<sup>st</sup> May 2025 (Thursday) to 4<sup>th</sup> June 2025 (Wednesday)**.

### Steps for Online Payment

- I. Open the Website: ([www.onlinesbi.sbi](http://www.onlinesbi.sbi))
  - II. Select “SB Collect” tab at the top.
  - III. Click check box at the bottom, accept and proceed.
  - IV. Under State Bank Collect
  - V. State of Institute > Assam
  - VI. Type of Institute > Education Institute > Go.
  - VII. Educational Institute Name > Select “**Online fee collection account NIT Silchar**” for admission fees payment > Select payment category (MBA Admission 2025-27 Registration Fee) and fill the required fields and submit.
3. If selected candidate fails to pay the Registration Fee mentioned above within the

- stipulated date (**4<sup>th</sup> June 2025**), their candidature shall be treated as cancelled and seat will be forfeited.
4. The forfeited seat will be allocated to the Waitlist Candidates.
  5. After making the online payment, the candidates must save the receipt copy in pdf format and email the same as a proof of payment to **doms.admission@mba.nits.ac.in** (**on or before 4<sup>th</sup> June 2025**) along with the following information:

  6. Candidates opting for Hostel Accommodation, the Mess Fees for the same shall be communicated in due course of time at the Institute website. Payment shall be made at the time of physical reporting (**17<sup>th</sup> & 18<sup>th</sup> July 2025**).
  7. The selected candidature for the admission to the MBA Programme 2025-27 is absolutely provisional. Candidates provisionally selected above and claiming seat must produce a valid certificate at the time of Physical reporting (**17<sup>th</sup> & 18<sup>th</sup> July 2025**) at the Institute.
