Pre-qualification criteria of the agency (to be furnished along with technical bid document duly filled up).

1.1 Contractor's registration:

- (a) For both Civil & Electrical work: Self-attested up to date (renewed) contractors of appropriate class and category issued by the competent authority.
- (b) For Electrical work: Self-attested up to date (renewed) Electrical contract license.
- (c) For Electrical work: Self-attested up to date (renewed) Electrical supervisory license issued by the competent authority.

2.1 Experience of having successfully completed similar nature of works during last 7 years ending last day of the month previous to the one in which applications are invited:

- (i) Three works each costing not less than the amount equal to Rs. 4.00 Lakh.
Or
- (ii) Two works each costing not less than the amount equal to Rs. 6.00 Lakh.
or
- (iii) One works each costing not less than the amount equal to Rs. 8.00 Lakh.

Completion certificate for the construction of similar work(s) should be in prescribed format given in Form - E of the technical bid document issued by the officer not below the rank of Executive Engineer of Govt./Semi Govt. Department.

3.1 Average annual financial turnover:

Average annual financial turnover on construction works should be at least Rs. 5.00 Lakh during last 3 consecutive financial year ending 2023-24 duly signed by the Chattered accountant.

4.1 Banker Certificate:

Banker certificate issued by the Scheduled Bank as per proforma given in technical bid document (Form B) for amount not below Rs. 4.00 Lakh during current financial year.

- (i) Bankers certificates should be on letter head of the Bank in original address to the Director, NIT Silchar in sealed envelope.
- (ii) In case of partnership firm, certificate should include names of all partners as recorded with the Bank.
- (iii) Name of the work should be written in the certificate as "Empanelment of Civil Contractors" or "Empanelment of Electrical Contractors".

5.1 G.S.T registration:

Self attested copy of G.S.T registration certificate. The agency should submit the GSTR-3B return along with payment receipt for the month of December, 2024.

6.1 EPF registration:

Self attested copy of EPF registration certificate including paid challan (not less than the minimum value) for the month of December, 2024.

7.1 ESI Registration: Self attested copy of ESI registration certificate including upto date paid challan.

8.1 PAN No.:

Self attested copy of PAN card.

9.1 An Engineer (For civil work: Civil Engineer & For Electrical work: Electrical Engineer) diploma with minimum five years experience in the required field or B.E. (For civil work: Civil Engineer & For Electrical work: Electrical Engineer) must be engaged by the contractor (Whose certificate duly self-attested, one copy photo & an undertaking by the Engineer is to be enclosed with the technical bid failing which the tender will not be considered) to supervise the work. The Engineer engaged must be familiar with all the works specified in the contract & must be acquainted with CPWD specification, manual

etc. The engagement of engineer is not mandatory for Contractor possessing technical qualification.

Cost of Tender paper (Non refundable) & Earnest money (Refundable) are to be transferred through online.

10.1 Tender paper signing authorization in case of partnership firm / company.

11.1 The tender, the tenders shall have to furnish an affidavit as under:

"I/We undertake and confirm that eligible similar work (s) has/have not been got executed through another contractor on back to back basis. Further that, if such a violation comes to the notice of Department, then I / We shall be debarred for tendering in NIT Silchar contracts in future forever. Also, if such a violation comes to the notice of Department before date start of work, the Director, NIT Silchar shall be free to forfeit the entire amount of Earnest Money deposit/performance Guarantee."

12.1 In case of partnership firm / company, Registered Partnership deed / Article of Association (respectively) to be submitted.

13.1 Email ID for relevant communication.

14.1 Check list (Technical bid document page no. 2 to 3) to be duly filled up along-with page numbering.

Tender of any contractor not accompanied with proper earnest money and incomplete tender, non submission of requisite documents (Self attested) under Sl. 1.1 to 14.1 of the NIT or in any form shall be summarily rejected.

Note: (a) Successful bidder has to sign a complete agreement before start the work.

(b) The bidders are required to submit any additional documents / clarification if asked for the participated tender.
