The contractor/agency is to satisfy the following conditions. Failing which the tender is liable for rejection.

Pre-qualification criteria of the agency (to be furnished along with technical bid document duly filled up).

1. **PAN No.:** Copy of PAN card.
2. **GST Registration:** Copy of GST registration certificate (including Annexure A & B). The agency should also submit the recent GSTR-3B return (for a month falling within past 03 months prior to the tender publication-date).
- 3.1. **Contractor's Registration:** Up-to-date (renewed) contractors of appropriate class and category issued by the competent authority.
- 3.2. **For Electrical Works:** Valid electrical contractor license (having jurisdiction for work in the state of Assam) along with valid electrical supervisory license of the supervisor.
4. **Work Experience:** Experience of having successfully completed similar nature of works during last 7 years ending last day of the month previous to the one in which tender are invited:

(i) Three works each costing not less than the amount equal to 40% of the estimated cost of work.

Or

(ii) Two works each costing not less than the amount equal to 60% of the estimated cost of work.

Or

(iii) One works each costing not less than the amount equal to 80% of the estimated cost of work.

Completion certificate for the construction of similar work(s) should be in prescribed format given in Form - E of the technical bid document issued by an officer not below the rank of Executive Engineer of Govt./Semi Govt. Department containing seal signature and office telephone no.

The Similar nature of works are defined as follows:

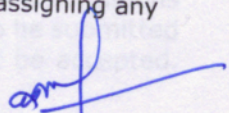
Sl.no. 02, 03, 04, 05 & 06: Experience of new work/ renovation/ maintenance of electrical installations.

5. **Average annual financial turnover:** Average annual financial turnover on construction works/ electrical works should be at least 50% of the Estimated Cost during last 3 consecutive financial year ending 2024-25 duly signed by the Chattered Accountant (CA) containing seal and Reg. No. of CA.
6. **Banker Certificate:** Banker Certificate issued by the Scheduled Bank as per proforma given in technical bid document (Form B) for amount not below 40% of Estimated cost during current financial year.
 - (i) Bankers' certificate should be on letter head of the Bank addressing to the Director, NIT-Silchar and should be uploaded/submitted in original.
 - (ii) Bankers' certificate should include the name of the work.
 - (iii) In case of partnership firm, certificate should include names of all partners as recorded with the Bank.
7. **EPF registration:** Copy of EPF registration certificate including a recent (for a month falling within past 03 months prior to the tender publication-date) paid challan (not less than the minimum value).
8. **ESI Registration:** Copy of ESI registration certificate including a recent (for a month falling within past 03 months prior to the tender publication-date) paid challan.
9. The tender, the tenders shall have to furnish an affidavit as under:
 "I/We undertake and confirm that eligible similar work (s) has/have not been got executed through another contractor on back to back basis. Further that, if such a violation comes to the notice of Department, then I / We shall be debarred for tendering in NIT Silchar contracts in future forever. Also, if such a violation comes to the notice of Department before date start of work, the Director, NIT Silchar shall be free to forfeit the entire amount of Earnest Money deposit/performance Guarantee."
- 10.1 Document for other than proprietorship firm: Partnership deed (for partnership firms), articles/memorandum of association (for company) etc.
- 10.2 Tender document signing authorization (in the form of power of attorney) for other than proprietorship firm.
11. An Engineer with diploma in Civil/ Electrical (whichever applicable) with minimum 05 (five) years' experience in the required field or B.E./ B.Tech (Civil/ Electrical) with minimum 01 (one) years' experience must be engaged by the contractor (Whose certificate duly self-attested, one copy photo & an undertaking by the Engineer is to be enclosed with the technical bid failing which the tender will not be considered) to supervise the work. The Engineer engaged must be familiar with all the works specified in the contract & must be acquainted with CPWD specification, manual etc. The engagement of engineer is not mandatory for Contractor possessing technical qualification.
12. Cost of Tender paper (Non-refundable) & Earnest money (Refundable) are to be transferred through online.

Tender of any contractor not accompanied with proper earnest money and incomplete tender, non-submission of requisite documents (Self attested) under Sl. 1 to 12 of the NIT or in any form shall be summarily rejected.

If any, holidays / strike falls during the notified days, the process will be continued on next working day.

Following modification is made in Para no. 5.2 for CPWD Works Manual 2024:

2. PG shall be 5% of the contract amount or as prescribed from time to time to be submitted in the form as prescribed in GCC. Performance Guarantee shall remain valid for a minimum period of sixty days beyond the date of completion of all contractual obligations as per GCC. In case of contracts where supplementary agreement is drawn, the fresh PG shall be obtained from the contractor @ 5% of the amount of the supplementary agreement or as prescribed from time to time. The PG received against the original work shall be released as per contract conditions.	2. PG shall be 5% of the Estimated cost put to tender (ECPT) or contract amount whichever is higher, or as prescribed from time to time, to be submitted in the form as prescribed in GCC. Performance Guarantee shall remain valid for a minimum period of six months beyond the date of completion of all contractual obligations as per GCC. In case of contracts where supplementary agreement is drawn, the fresh PG shall be obtained from the contractor @ 5% of the amount of the supplementary agreement or as prescribed from time to time. The PG received against the original work shall be released as per contract conditions.

4. No provision	4. A bid will be treated as abnormally low if the quoted bid amount is lesser than 80% of the estimated cost put to tender.
5. No provision	5. Requirement of Additional Performance Guarantee (APG) : In case of abnormally low bids as defined above, the bidder shall be required to submit Additional Performance Guarantee (APG) in addition to the Standard Performance Guarantee (PG). The amount of Additional Performance Guarantee (APG) shall be equivalent to the difference between the 80% amount of ECPT and quoted amount. (e.g. If ECPT is A and quoted amount is 0.7A then the amount of APG shall be

0.8A - 0.7A).
The Additional Performance Guarantee (APG) shall be in the prescribed format of Performance Guarantee and has to be submitted within the time frame prescribed for submission of Performance Guarantee. The other terms and conditions of release etc. of APG shall be same as that of PG.
