NOTIFICATION

Regular and registered students of NIT Silchar (satisfying other eligibility criteria) and desirous of contesting for various posts, can obtain **Nomination form along with Undertaking form** from the **Institute website**. No contestant would be allowed to submit more than one nomination from under normal circumstances.

- (i) Candidates shall have to submit the duly filled in nomination forms **in person** to the Returning Officer, Gymkhana Election 2025 along with copies of his/her grade sheets and I-cards (all self attested by the prospective contestants). A contestant would be required to attach a copy of his/her photograph, duly self attested, on the space provided in the nomination form. The Returning Officer reserves the right to verify the authenticity of the documents supplied and declaration made by the contestants etc. through cross verification of records available in various sections of the institute.
- (ii) Candidates need to submit documents with a consolidated page of write up/ listing in support of his involvement/ participation in similar type of activities related to the post applied for. Photocopy of any certificates in support is necessary as proof of claim.
- (iii) Every candidate, contesting for various posts will have to be proposed by one regular registered student and seconded by one regular registered student on the nomination form. Not more than one contestant can be either proposed or seconded by the same student. Proposer and seconder also sign in front of the Returning Officer at the time of submission.
- (iv) A candidate cannot propose or second himself or any other candidate contesting in the elections for any post.
- (v) No contestant shall apply for more than one post at the same time. In case more than one nomination form is received from the same contestant, all such nomination forms are liable to be rejected.
- (vi) Withdrawal of nomination, if any, could be made by the candidates by writing a letter to Returning Officer, Gymkhana Election 2025, within the dates/hours fixed for the purpose (already circulated).


